# **Terms and Conditions**

Please read these terms and conditions carefully before using Our Service.

### Interpretation and Definitions

#### Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

#### Definitions

For the purposes of these Terms and Conditions:

- Affiliate means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.
- Account means a unique account created for You to access our Service or parts of our Service.
- **Country** refers to: Florida, United States
- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Smarter Contact LLC, 1802 N Howard Ave Tampa, FL 33607.

# A2P 10DLC

According to the new 10DLC regulation, starting April 1st, 2022, all customers should provide additional data about their business to fulfill carrier requirements. Below is a list of the information required to continue uninterrupted service.

- Address/Street
- City
- State
- ZIP Code
- Country
- Email
- EIN (Tax ID Number)
- EIN Issuing Country
- Legal Company Name
- Volume Classification

We would not cancel the subscription if the information is not provided. Keep in mind, NOT being 10DLC registered will result in negatively-impacted SMS delivery rates.

We are strongly advising our SMS users to apply for 10DLC as soon as possible to mitigate additional carrier filtering and continue with high throughput.

### Carrier fines associated with the 10DLC violations

Mobile carriers could impose additional fees on some violations:

10DLC Long Code Messaging Program Evasion: This fee is applied when businesses use evasion techniques like snowshoeing, unauthorized number replacement, and dynamic routing could be cause of fine \$1000 per accident

Text Enablement: \$10 000 fee is applied when a 10-digit NANP telephone number is provisioned for SMS and sends out messages before verification of message sender ownership is completed.

Content Violation: T-Mobile may charge a \$10 000 pass-through fee for each unique instance of the third or any subsequent notification of a content violation involving the same content provider. Content violation is defined as sending messages in violation of the rules in the Code of Conduct, and are usually SHAFT violations (sex, hate, alcohol, firearms, tobacco) but also include spam or phishing, or messaging that meets the threshold of a Severity 0 violation per the CTIA Short Code Monitoring Handbook.

### User Accounts
